

GOLDFRAPP RADIO CITY MUSIC HALL TICKET GIVEAWAY

Sweepstakes may only be entered by residents of New York City metro area and entries originating from any other jurisdiction are not eligible for entry. This Sweepstakes is governed exclusively by the laws of the United States.

Winner will be selected entirely by Mute Records (Sponsor).

Only one entry per person. Entries must be received by September 10, 2008 at 12:00pm (noon) EST.

Sponsor is not responsible for lost, late, illegible, stolen, incomplete, invalid, unintelligible, misdirected, technically corrupted or garbled entries, which will be disqualified. One (1) winner will each receive two (2) tickets to attend Goldfrapp's performance at Radio City Music Hall on September 12, 2008. No other expense provided.

Winner and their guest must be (18) years of age or older as of September 12, 2008. Prizes are non-transferable. No substitutions or cash redemptions. Prizes may not be sold, bartered or transferred. The prize does not include any additional expenses, including, but not limited to transportation, incidentals, meals, telephone charges, travel insurance, souvenirs, federal, state and local sales or other taxes and surcharges which are the responsibility of the winner.
